General Course Description:

Law is a mechanism through which societies order social life, regulate behaviour and resolve disputes. Law influences and sometimes determines spatial and environmental relations and, dialectically, they transform law. Throughout the past twenty-five years, geographers have studied this interplay. This course is an introduction to the approaches geographers have used and to some of the substantive issues which they have encountered. More particularly it outlines approaches such as impact analysis, political economic analysis, and sociocultural analysis and it encourages discussion on topics such as the spacing of urbanism through tools such as zoning and social, cultural and environmental regulation through mechanisms such as protection of property generally; the interplay of property and environmental protection; environment, torts contract and liability; rights, privacy and surveillance; trespass law and restriction of the use of public space and; health law and the geography of health.

Note - The Themes and Topic section will include consideration of a variety of general topics including such things as Charter Rights, Privacy and Surveillance, Property – Trespass, Public Space, Land Use and Zoning, Environmental Law, Environmental Rights and Resource Management, and, Health Law and Health

Geography. The Student Presentations section may include topics within those areas and other areas so long as they fit with the study of geography of law.

Course Expectations and Objectives:

Objectives

To expose geography students to the variety of topics being explored by geographers interested in law as an object of study

To raise awareness about the range of research perspectives which inform work in the area of geography of law, many of which inform cultural and human geography generally

To impart basic concepts and knowledge about law and its geographic expression

To encourage students to explore the area by participating in weekly discussions, by making short presentations about course readings, by thinking about the geographic implications of cases and by doing research.

Students are expected to do weekly readings, to use reference material, to come prepared to discuss the readings, to ask questions and to take part in the class.
