**Description:** A critical examination of the current land use and development issues in which students are required to actively participate in exercises and discussions.

Prerequisite: Third or Fourth year academic status

#### **COURSE OVERVIEW**

This course deals with some of the most crucial issues facing North American cities in the 21<sup>st</sup> century. Topics include urban sprawl, deindustrialization, public transit and accessibility, population heath, urban renewal and heritage preservation. The course objective is not only to describe the origin and extent to which these contemporary problems exist, but also to examine how urban planners and policy makers are currently addressing (or not addressing) them and to explore alternative solutions.

To enrich the classroom discussion each topic will be explored using heavily-illustrated case studies. As most case studies will be focusing on crucial urban issues at a local and regional level, they with often align with current events unfolding in today's large selection of media. We will use the city of London as our "laboratory" exploring ideas, raising hypotheses, and diving in to the In addition to lectures delivered by the instructor, class discussion will revolve around assigned readings, videos, special guest lectures, student presentations, and relevant supplementary material.

Each lecture period will be conducted in the form of a seminar where active participation is required to make the course a success. This participation is critical to your final mark. Our goal for this class is to create an open environment in which each member of the class can feel free to share personal thoughts, explore opposing views, or debate the ideas of others in an intelligent and respectful manner.

# **COURSE MATERIALS**

There is no single textbook that you are required to purchase for this course. Students will be required to read a variety of journal articles, book chapters, government reports, newspaper articles, or blogs dependent upon the topic to be discussed during each week. Required readings will be carefully chosen to supplement topics to be discussed in class. Optional readings will also be identified for your benefit, should you wish to explore a topic further. Required readings will be assigned at least one week in advance to the class in which they will be required.
