#### 6. Evaluation

Students are responsible for material covered in lectures as well as the assigned readings. The assignments and activities are practical, interactive applications of course content and will be completed during class time. Detailed information about the essay will be provided early in the semester. The midterm exam will cover material studied from Jan 10 through Feb 14. The final exam is cumulative but heavily weighted toward material studied in the second half of the semester. Exams will consist of multiple choice, fill in the blank, and short answer questions.

#### 7. Missed Assessments

#### 9. Use of Electronic Devices

No electronic devices will be permitted during exams.

#### 10. Academic Offences

Scholastic offences are taken seriously and students are directed to read the appropriate policy, specifically, the definition of what constitutes a <u>scholastic offence</u>. The course essay is subject to submission for textual similarity review to the commercial plagiarism detection software under license to the university for the

detection of plagiarism. All essays submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com.

For assessments that are completed in pairs, each student must write their own identifying information (name, student number, and signature). Writing someone else's identifying information is an offense; any student who has been found to have done this will be given a grade of zero on the assessment.

Computer graded multiple choice exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.
