5. Course Objectives and Format

World Cities is an introductory course in urban geography that will take a global perspective to consider such pertinent topics as urban planning and design, urban growth and de-growth, sustainability and resilience, poverty, violence, and socio-economic inequality. After laying the theoretical foundations to urbanization and urbanism, the course will take an around-the-world journey to highlight different opportunities and challenges of distinctive world cities such as New York and Shanghai. Students who take this course will be: (1) given lots of active learning opportunities; (2) allowed to experience different cultures and; (3) be challenged to imagine themselves as active participants in the vast global network of urbanized humanity.



Given our new on-line environment, it will be critical that you develop a weekly routine to complete your courses. Since the entire course content will be delivered asynchronously, the onus will be on you to set aside the required time to complete the course readings & video viewings as well as to complete the handouts, assignments, quizzes and exams. I will do my best to facilitate your learning.

Asynchronous work (3-5 hours every week): Every week you will be assigned to read 1 chapter from the course textbook. I will create voice-over powerpoints for all major topics covered which will have embedded video links for you to view. You will have to complete a weekly quiz and upload your weekly handout by 11:55pm EST each Tuesday as indicated on the schedule. Tuesday, Wednesday and Thursday you will have some more work to do on that week's topic by commenting on the online OWL "forums". The individual project will also be completed asynchronously over the course of the term.

10.1. Attendance & Participation (10%):

Participation is a fundamental part of the learning environment. You will need to participate every week on OWL "forums" and post substantial responses to the questions being asked. be ready to participate actively in the communal learning. Students are asked to follow the ABC of commenting, Acknowledge what was said before, Build on it and Conclude. The weekly handouts will also constitute part of your participation grade.

10.2. Quizzes (10%):

In order to help you assess your mastery of each week's course content, you will have to complete a short quiz (using OWL) of a few questions by Tuesday evening each week. The questions will be structured to test your basic comprehension of the course content. Some of the questions from the quizzes may make it onto the mid-term and final exams. For each week, course materials will be announced well in advance and you will have 24 hrs prior to the deadline to answer the questions. Final grade will be based on the average of 9 quizzes.

10.3. Mini-Assignment (10%):

Students will actively collaborate in course content creation by compiling the following for a world city region assigned by the instructor: 2 photographs with short descriptions of what they are showing and 4 exam questions/answers based on the course textbook for that particular world city region. (10%)

10.4. Research assignment (25%):

In mid-September you will be asked to choose a world city to research for the individual research assignment. You will select either one strength or one challenge for that world city and make the case for it. For example, here is one title based on a city's strength: "Ethnic and racial diversity makes Toronto one of the world's greatest cities". Select between 5-10 sources to back your claim which you should lay out in a 5-page article that will also include your references, 2-3 figures (may include pictures, maps, tables or graphics). I will be happy

to go over your assignment with you at any stage of preparation. Part 1 of the research assignment is due October 27th and will consist of an annotated bibliography for your research topic along with a statement of your research topic. Part 2 of the research assignment is the completion of the research paper.

10.5. Exams (45%):

There will be one mid-term exam (worth 15%) and a final examination (30%). The mid-term will be held on October 20th. The final examination will be scheduled by the Registrar during the December examination period. The examinations will consist of a mixed format questions including multiple-choice, fill-in-the-blank, short answer and long answer. The long answer question(s) will be provided well in advance of the exam. The exams will be conducted on OWL "Tests & Quizzes" and be timed. You will have 2 hours to finish the mid-term and 3 hours to finish the final exam in a 24-hour window. Both exams will be based on material covered in lectures, assigned readings, exercises and videos. The final examination will include material from the entire term.

11. Accommodation Policies

Academic Consideration for Student Absence

Students will have up to two (2) opportunities during the regular academic year to use an on-line portal to self-report an absence during the term, provided the following conditions are met: the absence is no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted on the syllabus. Students are not able to use the self-reporting option in the following circumstances:

- for exams scheduled by the Office of the Registrar (e.g., December and April exams)
- absence of a duration greater than 48 hours,
- assessments worth more than 30% of the student's final grade,
- if a student has already used the self-reporting portal twice during the academic vear

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate if the absence is medical, or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office to obtain more information about the relevant documentation.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.

12. Make-up Examinations

All documentation for missed exams must be provided to the Academic Counselling Office within 48 hours of the scheduled exam, otherwise the instructor will assign a grade of zero. Make-up exams will be granted with approved documentation only and only for the final exam. Any student who misses the mid-term with documentation will have their final exam account for 40% of the final mark.

The format and content of make-ups may differ substantially from the scheduled test or examination.

13. Use of Electronic Devices

This course requires that you have an electronic device, ideally a desktop or laptop, that can connect to the internet. Given that this is an online course, you will be using this device to perform most class activities.

14. How to Be Successful in this Class:

Students enrolled in this class should understand the level of autonomy and self-discipline required to be successful.

- 1. Invest in a planner or application to keep track of your courses. Populate all your deadlines at the start of the term and schedule time at the start of each week to get organized and manage your time.
- 2. Make it a daily habit to log onto OWL to ensure you have seen everything posted to help you succeed in this class.
- 3. Follow weekly checklists created on OWL or create your own to help you stay on track.
- 4. Take notes as you go through the lesson material. Treat this course as you would a face-to-face course. Keeping handwritten notes or even notes on a regular Word document will help you learn more effectively than just reading or watching the videos.
- 5. Connect with others. Try forming an online study group and try meeting on a weekly basis for study and peer support.
- 6. Do not be afraid to ask questions. If you are struggling with a topic, check the online discussion forums or contact your instructor and or teaching assistant.
- 7. Reward yourself for successes. It seems easier to motivate ourselves knowing that there is something waiting for us at the end of the task.
