# 2. Calendar Description

A survey of the methods and models used to understand human responses to hazards. The course reviews the rich tradition of hazards research in geography, particularly through the lens of social science. The course will include discussion of both natural hazards and technological hazards as examples.

#### 8. Evaluation



Students are responsible for material covered in modules as well as readings and videos. Discussion questions are opinion-based and are each worth 1% of the course grade. Assignments are practical, interactive applications of course content and are each worth 2% of the course grade. Quizzes are based on the module content studied during that week and are each worth 1.5% of the course grade. Detailed information about the essay will be provided early in the semester. The midterm exam will cover material studied from May 6 through June 7. The final exam is cumulative but heavily weighted toward material studied in the second half of the semester. Exams will consist of a variety of question types.

#### Requirements

Students must complete at least 3 assignments to pass the course. Students must earn a passing grade on the essay to pass the course.

#### **Late Assessments**

Assignments submitted late without approved documentation will be subject to a penalty of 10% per day. However, an assignment cannot be submitted after it has been graded and its grades have been posted.

Grades will not be adjusted based on need. It is important to monitor your performance in the course. You are responsible for your grades in the course.

#### **Academic Consideration for Missed Assessments**

Students seeking academic accommodation on medical grounds for missed *assignments*, *discussion questions*, or *quizzes* should contact the instructor within 48 hours of the assessment deadline. If a valid reason is provided, the accommodation for the above assessments involves transferring the weight to the final exam.

## 10. Make-up Examinations

A make-up exam will be granted with approved documentation only. All documentation for missed exams must be provided to an Academic Counselling Office within 48 hours of the originally scheduled exam and students must notify the instructor of the absence within 48 hours of the originally scheduled exam. Otherwise, a grade of zero on the exam will be assigned. The content of make-up exams will differ from the originally scheduled exam. There is no make-up for the midterm exam; if it is missed for a valid reason then the weight of it will be transferred to the final exam.

The course essay is subject to submission for textual similarity review to the commercial plagiarism detection software under license to the university for the detection of plagiarism. All essays submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com.
